

2019 Ottawa County Fair Calf Scramble

Rules and Regulation

- Open to contestants 15 years of age or older
- A T-shirt will be included with entries received in the Fair Office on or before July 10th. Extra shirts will be available for purchase while supplies last
- Entry fee is \$10 and must be paid at time of entry, Fee is non-refundable.
- Participants will take into the arena a rope halter supplied by the scramble coordinators. Halter cannot be used as a lariat. Halter must be placed on the head of the animal in the usual and correct way.
- At no time will a participant be permitted to tie the rope to his/ her body or belt.
- Each participant will attempt to catch and hater one of the calves released.
- If a participant has hold of a calf, no other participant will be allowed to touch the calf until it breaks away.
- If a participant catches the calf by the tail, he/she will be given a reasonable amount of time to work around to its head; otherwise, the referee will order him to let the calf go.
- If two or more participants catch the same calf, the calf will be turned loose.
- A participant who secures and properly halters a calf and contains it for 30 seconds will be declared a winner when so indicated by the referee. The winner will receive the monetary amount connected to that calf.
- Unnecessary roughness will not be tolerated; participants will be disqualified and calf will be set free. Poor sportsmanship automatically disqualifies scrambler.
- There will be a 20 minute time limit for each heat.
- Judge's decision is final.
