Rules and Regulations

- Contest is open to children ages 8 and younger
- Entries must be turned in by July 10. **LATE ENTRIES WILL NOT BE ACCEPTED!**
- A T-shirt will be included with entries received in the Fair Office on or before July 10th. Extra shirts will be available for purchase while supplies last
- Registration fee is \$5 and must be paid at time of entry. Fee is non-refundable.
- At least one parent or guardian must be present during the scramble.
- Contestants will be instructed on proper catching technique at time of event.
- All contestants must be present for check-in 15 minutes prior to the start of the event. Late arrivals may not be permitted to compete.
- Contestants will be divided into age divisions.
- Cash prizes will be awarded by the order in which the chickens are caught. A catch doesn't guarantee prize money, as the number of paid spots will be determined by class size and sponsorship.
- To be deemed as having "caught a chicken," the contestant must bring the chicken to the officials/cage in the arena. Officials will be in the arena to assist, especially with younger age groups.
- If a participant has hold of a chicken, no other participant will be allowed to touch the animal until it breaks away.
- If two of more participants catch the same chicken, the animal will be turned loose.
- Unnecessary roughness will not be tolerated; participants will be disqualified and the animal will be set free.
- All judges' decisions are final.
