

# **Livestock and Equine Fact Sheet**

#### **Show Details**

- Market and equine shows will be run in much the same way as previous years.
- Designated areas will be available for trailers and tack. Please refer to the traffic map.
- Social Distancing guidelines and safety measures put in place by the Fairboard should be adhered to.
- Seating and spectator access may be reduced.
- All exhibitors are responsible for their own bedding.
- Grand and Reserve Champion market beef, sheep, goats, and hogs will be tested and taken to slaughter at Hasselbach Meats at the completion of the show day. The meat from only those animals will be sold during the online auction.

## Monday, July 20th

#### Tuesday, July 21st

### Wednesday, July 22<sup>nd</sup>

9:00am Horse Show 7-9:00am Beef move in 12:00pm Beef Show \*Champions go to Hasselbach's immediately after beef show\*

## Thursday, July 23<sup>rd</sup>

8-9:00am Goats and Rabbits move-in 9:00am Goat weigh-in from the barn 11:00am Rabbit Show 3:00pm Goat Show \*Champion Goats go to Hasselbach's immediately after goat show\*

#### **Animal Logistics**

- All animals will be checked in during the listed daily move-in period.
- DUNF forms must be turned in before the beginning of the show.
- With the addition of camping, exhibitors have been given the option to bring the animal in on Sunday. If so choosing, the animal will be the sole responsibility of the exhibitor. Superintendents may set rules for their barns and how they will handle the week. Superintendents/Liaisons will be periodically on the grounds, but no guaranteed supervision will be granted by Sr. or Jr Fair staff outside of that species' show day.
- Exhibitors may choose from one of three options
  - A. The animal arrives on the grounds during the move-in period for that species and must be removed from the ground the same day.
  - B. The animal arrives on Sunday, July 19<sup>th</sup> between 6:00-8:00 pm and must be removed from the grounds at the end of the show day.

- C. The animal arrives on Sunday, July 19<sup>th</sup> between 6-8:00 pm and must remain on the grounds until Sunday, July 26<sup>th</sup>. All animals must leave by 6:00 pm July 26<sup>th</sup>.
- Exhibitors must indicate their selections by completing and returning the Animal Intention Form, found attached and on the fair website, to the Sr. Fairboard Office by July 6<sup>th</sup>
- Animal Intention Forms can be returned via drop box at the Sr. Fairboard Office, email (ocfair@amplex.net), or in person during office hours:
  - o Monday June 29<sup>th</sup> Thursday July 2<sup>nd</sup> . . . 9am-6pm
  - o Friday 3<sup>rd</sup> . . . 9am-1pm
  - o Monday 6<sup>th</sup> . . . 9am-6pm
- Exhibitors desiring move-in or release variance must provide a written request to <a href="mailto:ocfair@amplex.net">ocfair@amplex.net</a> describing the need for such allowance by the July 6<sup>th</sup> deadline. The Jr. Fair Committee will have final say in the approval of such requests.
- Move-In, Move-Out, and show day traffic patterns will be posted on the Ottawa County Fair Facebook page and website.

#### **Livestock Sale**

- The livestock portion of this year's sale has been eliminated per the decision by OCAS Board of Directors on May 5<sup>th</sup>. The only animals that will sell for meat are the Grand and Reserve Champions. All other animals will be the responsibility of the exhibitor.
- There will still be an online premium sale for fair exhibitors and all carcass registrants. More information will be provided by Livestock Sale Committee.
- Livestock Sale Committee has secured an option in every species for any exhibitor who has not yet secured an end market for their animal. Any interest in utilizing those options should be designated on the Animal Intentions Form.
- \*All temporary changes made this year and listed on this Fact Sheet, OCAS Press Releases, or other means of communication supersede any previous versions of the Jr. Fair Handbook. Anything in the handbook not addressed by these releases shall be upheld by the authority in the Jr. Fair Handbook. Please understand the need for these alterations during this abnormal year.
